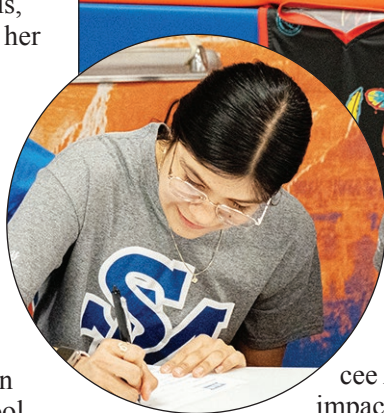
On Monday, April 25, in front of a room full of her family, friends, coaches, teammates and supporters, Westwood High School senior Nyese Jones signed her letter of intent to continue her basketball career on the collegiate level at South Mountain Community College.

Jones has been on the Lady Warriors varsity basketball team since she was a freshman and leaves some big shoes to fill. As she leaves Westwood, she is the all-time program leader in points, assists and steals, and she scored more than 1,000 points in her high school basketball career.

Before signing her letter of intent, Jones was recognized by her parents and coaches for her hard work and dedication to the game.

"To see Ny going from a little scrawny ... kid who was always following Day (her sister Daycee Achin) and some of the older girls around to [growing] and being unbelievably selfless this year set an example for a lot of the girls in this program," said Westwood High School basketball coach Ron Campton. "But more than anything, it's just been ... great to see everyone come together around someone who is unbelievably special and talented."

Westwood High School girls assistant basketball coach Casey Sanderson expressed his gratitude to Jones and her older sister Day-

cee Achin for their impact on the team and bringing the love of basketball back into his life.

"[W]atching Ny grow up as a player made the game fun again," said Sanderson. "I fell in love with the game again. ... [I]t has to do with the support from the parents ... [and the] great coaches we had. It became a big

bond; it was a family thing and I wouldn't give it up for anything in the world."

Jones's parents, JJ Jones and Sarah Achin, thanked everyone for their support of their daughter. Achin explained that Jones struggled with the decision to play college ball out of state, but everything fell into place.

"We're excited for her. She doesn't know how much light she brings to that court,"

Council Enacts Ordinances to Implement Special Domestic Violence Criminal Jurisdiction

With the 2022 Violence Against Women Act (VAWA) Reauthorization Act being signed into law, tribal governments will soon be able to take action on the language within the legislation.

Tribes can start exercising the language relating to special tribal criminal jurisdiction on October 1, but due to the complex nature and swift reauthorization of the act, changes will not be automatic for all tribal governments.

In the Salt River Pima-Maricopa Indian Community, what comes next after the reauthorization will be discussed in Council and district meetings throughout the summer.

There are, however, ordinances that went into effect on May 1 that allow SRPMIC courts to prosecute non-Native offenders for crimes of domestic violence and order-of-protection violations, if it can be proven that the defendant has adequate ties to the Community. This includes changes to the Community's jurisdictional statement when it comes to those crimes and violations, and it also includes the addition of a new jury pool.

The jury pool for these cases

will include eligible enrolled members of the Community and Community government employees. In the future, the Community may add additional non-Indian residents as part of the jury pool.

"I think that, from a policy perspective, being able to hold offenders responsible in the community where they commit those crimes, rather than having to depend on an outside agency, the U.S. Attorney's Office, is an important consideration to make."

These changes are all that have gone into effect, because that is all that the current law allows.

Council enacted these ordinances on February 23 to implement Special Domestic Violence jurisdiction (SDVCJ) pursuant to

Coming Summer 2023: Banner Sports Medicine Center in Salt River Business Corridor

On Wednesday, April 27, a groundbreaking ceremony was held for the new three-story, 80,000-square-foot Banner Health sports medicine center. The one-stop destination for sports medicine services and specialists will be located along Loop 101 northwest of TopGolf in the Pima Corridor.

The \$54 million full-service facility will be available to everyone from seasoned sports professionals to up-and-coming youth athletes. Services will include orthopedic surgery, imaging, physical therapy, primary care sports medicine, concussion treatment, strength and conditioning, sports nutrition and more. Banner Health already

works with Arizona's professional sports teams, including the Phoenix Suns, Arizona Diamondbacks, Phoenix Mercury, Phoenix Coyotes and Tucson Roadrunners, as well as University of Arizona sports and teams from 33 Arizona high schools.

"This sports medicine center ... is expanding our presence in the Northeast Valley. The center will give us the ability to reach a diverse population of people who participate in sports, not only in Arizona but across the country. There is also a significant philanthropic component that is connected with this project that will ensure young people across the state can fulfill their athletic aspirations," said Quentin P. Smith Jr., chairman of the Banner

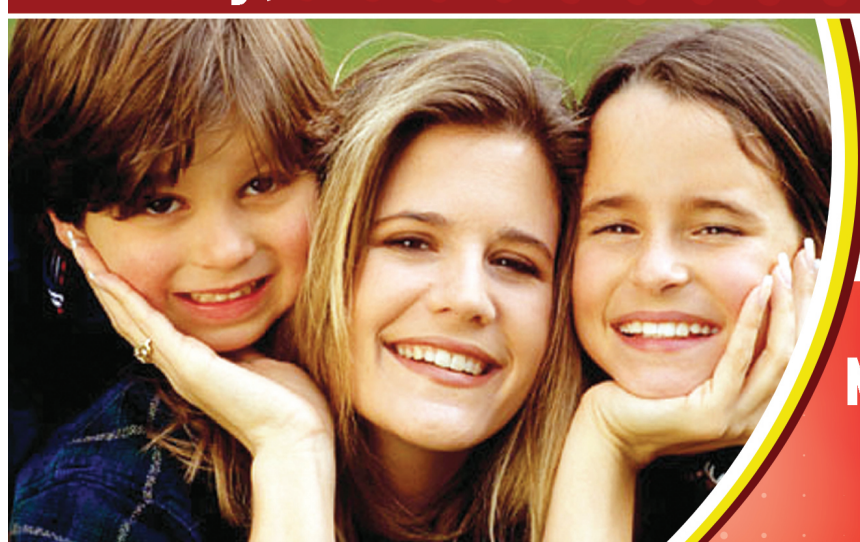

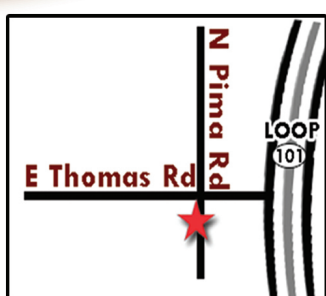

GIS Team New Interactive Website Helps SRPMIC Department Improve Communications

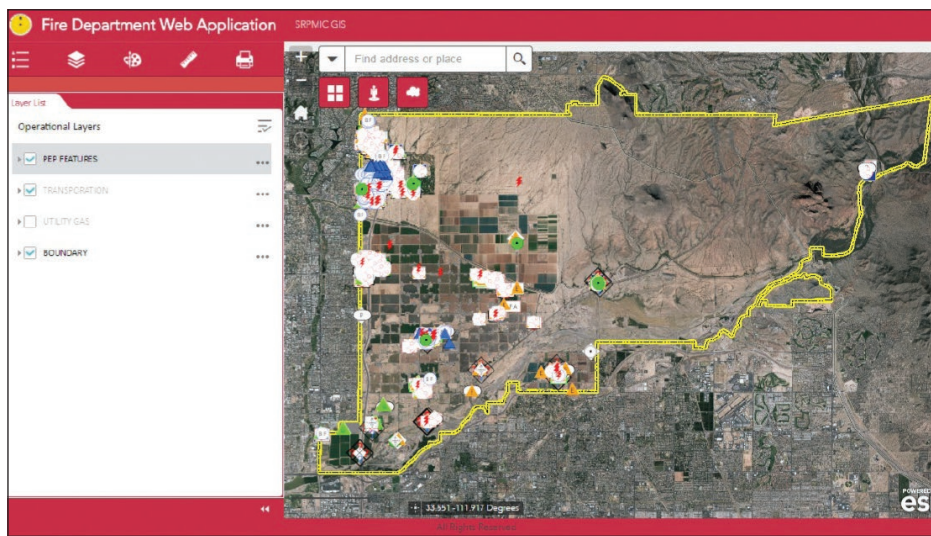

In March, the Salt River Pima-Maricopa Indian Community’s Geographic Information Systems (GIS) Team gave a presentation at the Council District C meeting to inform Community members about an interactive website and mobile app they have been working on and to share information about their past and future projects.

What is GIS, you ask? Engineering and Construction Services Division Manager Rueben Malin explains that GIS is a mapping tool to collect, manage and analyze data to visualize spatial patterns. Recently, the GIS team worked on the question of where is the best location to build the next SRPMIC fire station to maximize coverage and uphold the standard of a four-minute (or less) drive time for an emergency.

“We answer the questions of where and how; for example, finding the best location for the next fire station based on specific criteria, such as where the Community has land and what type of structures are in that area,” said Malin. “We maintained a structure layer (map or dataset) of all types of government, commercial, residential and storage [structure sites], but in this project we just looked at residential, commercial and government. We did an analysis, trying to get the best location for a future station.”

Through interdepartmental data sharing, the GIS Team can complete analysis and answer specific questions important for Community planning and activities—for example, how many

enrolled residents over age 18 are impacted by the closure of the Beeline Highway due to the Ironman triathlon race.

“This information helps us figure out who will be affected by the Ironman and its road blockages,” said Malin. “By pinpointing the locations of homes and residents affected, the Community can help accommodate these residents during these closures.”

Introducing Azimuth

Through its interactive website and mobile app, called Azimuth, the GIS Team has created a one-stop shop for tribal employees to get assistance in matters such as finding new locations for police and fire substations, viewing parcels of allotted and tribal lands, easements and proposed easements,

street names and more. All this data and information helps improve communication between SRPMIC departments and divisions.

“The access to the [web]site is behind the SRPMIC firewall, so only government employees have access to it, and permissions are based on job duties,” said Malin. “We have multiple levels of security. We want to emphasize that [the website] contains information approved by the data owner and shared [with] tribal employees based on their job function, and it does not contain personal information. Protecting members’ personal information is a high priority to the GIS Team and the tribal government. The GIS Team promotes and maintains security measures per Tribal Policy 1-8a, Confidentiality. We’re following this policy to protect the data to

make sure we are sharing [information appropriately].”

Malin provided a quick demo of Azimuth. As he opened up the site, there was a disclaimer that the employee has to agree to in order to continue to use the information on the site. Then they can enter the SRPMIC General Purpose Mapping Application site. The site also includes aerial photos of the Community that go back to the 1930s, showing the growth of the Community over the years.

Notable Projects

The GIS Team has used GIS data to improve Community addressing, such as clearing up issues of two homes using the same address and the public safety problem that causes for the police and fire departments. They also work with Google on updating Native language street names and providing 911 dispatch with specific data so they can more easily locate residents. They have provided assistance to Public Works with setting up its asset management software, called Lucity, a program to keep track of capital assets like road equipment, manage work orders and schedule preventive maintenance. These are just a few projects that the GIS Team has worked on as they continue to provide information services to help the SRPMIC government work more efficiently and better serve the Community.

Health Board of Directors. "This project is an important collaboration of partners dedicated to helping individuals reach their fullest athletic potential by having access to state-of-the-art facilities. [It] is particularly special to us because it is being built on the sacred land that is home to the Salt River Pima-Maricopa Indian Community. The building design will specifically reflect the tribe's rich culture. We are particularly grateful to the SRPMIC for giving us the opportunity to use this land in such a meaningful way."

The state-of-the-art facility is coupled with physician education and research with the University of Arizona to train residents, fellows and medical students, explained Evan Lederman, M.D., chief of sports medicine with Banner Health.

"One of the unique features will be the biomechanics lab, where motion-capture technology will allow us to do real-time analysis of athletic performance," said Lederman. "This includes baseball with pitching and batting, and we will have a golf simulator that is unlike anything you have seen in a golf shop. We will also have the ability to do motion analysis on court sports, such as basketball and volleyball, and running sports on a state-of-the-art biomechanics treadmill. Not only will this technology give our sports professionals valuable information to help [them] enhance their performance or return from injury, it will also help us conduct novel research to help our athletes in the future."

Adventures in Food Inspection

The Environmental Health Program (EHP) is a branch of the Public Health Division under SRPMIC Health & Human Services Department. The EHP was developed in 1996 to create a program similar to services provided by the Indian Health Service. With the Community's development and growing food operations, the EHP has grown to a staff of three: Christopher Henke, program manager; Naomi Evanishyn, environmental health specialist; and Anthony Phillips, environmental health technician.

There are approximately 200 permitted food establishments in the Community. The EHP inspects all these food facilities bi-annually. Before an establishment opens, it must submit plans for the proposed business and, if necessary, submit formal plans to the SRPMIC Community Development Department for review.

After approval from the various tribal departments, the EHP conducts a final construction inspection. After receiving the authorization to operate, the business must apply for a food permit and pay the necessary fees.

Conducting regular food inspections is essential to the health and well-being of the general public. This type of work requires training and certification to be administered appropriately. In this and future articles, the EHP hopes to make readers more familiar with our services and will provide examples of how we conduct food inspections.

Here's what happens during a typi-

cal restaurant inspection.

Before arriving at the restaurant, I make sure to have all my necessary supplies. Here is a list of the items I bring: notepad, pen, disposable gloves, work ID badge, comfortable non-skid shoes, hair tie, digital thermometer, alcohol wipes (for the thermometer), flashlight, test paper for measuring sanitizers, inspection sheets, and a fanny pack to carry the supplies. Often we will review the previous inspection reports to verify that any previous citations were corrected.

Upon arrival at an establishment, we ask to see the manager or person in

charge. A discussion about the routine inspection and request for all employee food handler cards is customary. It is up to the person in charge if they would like to accompany the inspector on the survey walk-through.

Each inspector has their own unique method of conducting the assessments; for me, my next stop is checking the hand sink. A dry hand sink is not a good sign, because it means kitchen staff have not been washing their hands. Not having soap or disposable paper towels nearby also tells me a lot! Some kitchens are large enough that they may have multiple hand sinks, so one must keep that in mind when doing the check.

Next, we visit the dock or delivery areas at the back of the kitchen. Food and supply delivery areas require inspection to ensure that perishables are not kept outside for long periods and items are stored correctly. This will also give me the opportunity to check the dumpster and mop sink for cleanliness and any signs of pests, such as rodents or insects. If there are no critical issues observed, it is time to begin the indoor inspection.

SRFD Fire Prevention Tips

As we head toward summer and the weather begins to get hotter, Salt River Fire Department Fire Marshal Dustin Zamboni shares some summer safety tips to protect your family, pets and home.

After the record-breaking rainy season last year, there is an abundance of weeds and grass growing in yards around the Community. This is a huge factor in causing large fires, explained Zamboni. Dried-out weeds and grass can ignite easily.

"I do all the fire investigations, and I have seen how fires were started with a piece of broken glass reflecting the sunlight and igniting a fire in the weeds," said Zamboni. "Another case was when a bottle of water sitting in someone's car started a fire. The sun pierced through the car window and through the water bottle and caught the back seat on fire."

Grass and weeds may seem like a little thing, but they are large contributing factors in how fires get started. Zamboni and the SRFD recommend that all Community residents have a 30- to 100-foot clearance zone free of weeds and debris around their homes and property.

"We understand that some members are physically limited; in that special case, call me at the fire department and I will come out and help," Zamboni offered. "Engineering and Construction Services has the Senior Home Repair and Replacement Program (SHRRP), which can help as well." While limited assistance is available, homeowners should understand that the SRFD is not a landscaping company.



In Zone 1 keep up to 30 feet of your home clear of any vegetation or other items that could catch fire, Zone 2 extends from 30 feet to 100 feet out from your home to your property line; keep your lawn mowed, remove fallen leaves, twigs, bark and small branches to help prevent the spread of a brush fire.

Another tip: Make sure all the smoke detectors in your home are working. Most fatal fires happen in the middle of the night, and smoke detectors will help warn you and your family in time to escape a fire.

Again, the SRFD is happy to offer some assistance. "We have several smoke detectors at the fire station. If you call my office, we can set up a time and date to get those installed if any Community members need them," said Zamboni. "The smoke detectors are battery operated and last for 10 years."

The last tip that Zamboni wanted to share is about water safety. With the weather getting hotter, it is important to watch your children around water and also avoid swimming in the canals.

"We recommend you go to the Com-

munity pools," said Zamboni. "You might not think that swimming the canal is a big deal, but there is algae that grows on the floors of the canal that can cause you to slip, fall and hit your head, and the water can easily overcome you." The canal water itself is polluted, he added. "There are also chemicals in the water used for agricultural purposes, and swallowing that could be problematic." Also, to prevent bacteria-caused illness, never swim in unclean water, including small lakes or ponds, if you have an open sore or a recent cut or scrape anywhere on your skin.

What is LIHEAP?

- * LIHEAP is a federal grant that offers energy assistance to the residents of SRPMIC. Assistance is available to enrolled and non-enrolled community members. However, the applicant must reside within the boundaries of SRPMIC.
- * Additional funding may be available to applicants that are senior citizens (55+), disabled, and children under 6 years old in the household.
- * Under the LIHEAP grant appliances, (water heater, range or refrigerator) are available under the crisis assistance.
- * Limit one per household and on a first come first serve basis.

How to qualify:

- * To qualify for the LIHEAP program, the applicant's annual income must fall at or below 150% of the federal program guidelines.

Applicant Requirements:

- * State driver's license or identification card (state/tribal) for all adults in household.
- * Social security cards and/or birth corticates for all members in household including children.
- * Annual income verification for all household members 18 years of age or older. (per-capita, lease payouts, employment paystubs, social security, unemployment insurance, disability, self-employment income, etc.)
- * A copy of most current utility bill in the applicant's name.

Salt River Fire Department: Recruitment Program Update

Last summer, the Salt River Fire Department was awarded a federal SAFER grant (Staffing for Adequate Fire and Emergency Response) to improve staffing levels within the organization. The grant consisted of \$2.5 million to cover additional personnel. This gave SRFD the opportunity to develop a recruitment program to help Salt River Pima-Maricopa Indian Community members and other Native Americans learn the skills and navigate the process for becoming a firefighter.

Chief Tsosie Wood and two firefighters, Jayce Johnson and Aaron Morales, put the program together to recruit Community members so they can fill empty positions in the department. The recruitment program started in August 2021. Participants learn the material covered on the written exam, undergo physical training for the Candidate Physical Ability Test and prepare for the oral board interview.

The program started with 21 Community members and nine from other Native communities, such as Gila River, the Navajo Nation, the White

Mountain Apache, and Sac and Fox. In the first group of recruits, 19 individuals ended up taking the written exam.

Ten Community members passed, and the nine who did not will be offered employment through the Underfill Program, explained Fire Chief Daryl Dash.

Out of those recruits, nine Community members passed both the physical and written tests and started at the Fire Academy on March 2.

"This is the largest Community-member hiring that has ever been done in the history of the [Salt River] fire department. The last large group of Community members hired was back in 1983, when they hired six Community members," said Dash. "It's been a real success for us in regards to having this grant and funding to hire more Community members. We are focusing on hiring six more under the Underfill Program."

SRFD Paramedic Joan Wood Is First Female SRPMIC Member to Become Captain

Longtime Salt River Pima-Maricopa Indian Community Fire Department employee Joan Wood has been promoted to the position of fire captain, making her the first female SRPMIC member to hold the title. Wood follows in the footsteps of Salt River Fire Department Battalion Chief Melanie Lake to move up in the ranks and take on a higher role in the department.

Wood started her career with the SRFD in 1999, attending the Mesa Fire Academy and graduating as an EMT

to work for the Community. Throughout the years she took steps to improve her skills as a firefighter/EMT. She went to school to become a paramedic in 2008, and shortly afterward she attended nursing school through the Paramedic to RN Bridge Program. This gave her the ability to do more in the medical field to help her patients.

“Being a paramedic just seemed like a natural progression. When you are an EMT, you are restricted to the basics of what you can do,” said Wood about why she chose to become a paramedic and took on nursing school. “I wanted to help our patients in a more advanced capacity.”

Although she is now a captain, Wood will continue her duties as a paramedic. As captain she will take on an added supervisory role as the first line supervisor, right above fire engineer.

“I will be supervising Station 291,” said Wood. “The battalion chief oversees all four stations; I will be reporting to the battalion chief.”

Over the years Wood also worked on becoming an engineer to be able to drive the fire truck.

She said she looks forward to working with a good solid crew that works well together.

“We could be in a difficult situation, but when you have the right crew and the right people who have the right mindset, it makes things easier because things run smoother,” said Wood. “Giving good customer service is rewarding, keeping

everyone safe and doing what we love to do.”

Currently there are only four women in the ranks of the SRFD, Wood explained.

“It’s always a plus to have a woman on the job, because you don’t know what you will be running into,” said Wood. In some circumstances with a female patient, “It might be ‘woman thing,’ and they might be more comfortable with you helping them [rather than a man]. And women have that motherly instinct that comes into play sometimes.”

Wood encourages all those who are seeking a career in fire services, female or male, to take all the opportunities they are given and just go for it.

“I love this job and mentoring and teaching the new firefighters that are coming on,” said Wood. “I look forward to being a good role model, giving the best customer service to the Community, and being a good employee and supervisor.”

Nutrition Services at River People Health Center Welcomes Those Seeking Healthy Habits

One of the services offered at the new River People Health Center helps Salt River Pima-Maricopa Indian Community members, employees and other enrolled affiliated tribal members gain knowledge about eating well as part of a healthy lifestyle.

The Nutrition Services department started serving diabetes patients with one-on-one appointments in April. It welcomes any patient who wants to lose weight or has a medical condition that might benefit from a more healthy diet. Services are offered not only to individuals, but to families and parents who want to learn how to serve healthy meals to their children.

Currently, the two registered dietitians at Nutrition Services, Katherine "Kat" Latour and Elizabeth "Libby" Boudreau, are booked two weeks out. "It's keeping us on our toes," said Latour. "The Community is so determined to learn about healthy nutrition. It's exciting."

Since its opening, Nutrition Services started an eight-week course called Thriving with Diabetes, which has 12 participants. The course reviews medications, healthy eating, exercise and the special healthcare needs of diabetes.

Latour and Boudreau are gearing up to start a class called Basics on a Budget, a six-week cooking course that teaches basic cooking skills and how to safely prepare food, plan meals, create a grocery list and stay within a budget.

They also have started doing recipe tastings out of the Nutrition Services



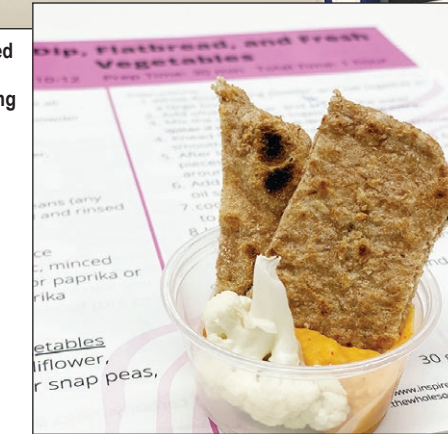
River People Health Center's Nutrition Services Registered Dietitians, Katherine "Kat" Latour and Elizabeth "Libby" Boudreau test out healthy recipes to add to their upcoming class called Basics on a Budget.

Teaching Kitchen at the RPHC. The recipes will be used for the Basics on a Budget course that will be held this summer.

"We found a bunch of recipes and tweaked them to make them more nutritious and less expensive," said Latour. "We are letting the public taste them to make sure they like them. The course is set to start in late July or early August, but we will provide the course with the Journey to Recovery Program before offering it to the public."

Latour and Boudreau say their goal for Nutrition Services is to improve the health of the people they work with, and the Community as a whole, through classes and other interventions that support good nutrition.

"I would like to see [the SRPMIC]



not be the Community with the highest rate of diabetes per capita in the world, so if we can be a part of changing that, it would be awesome," Latour said.

Interim Principal at ALA Sets Example for Work-Life Balance

Barb Wilkinson, interim principal at the Accelerated Learning Academy (ALA) on the Salt River Pima-Maricopa Indian Community, is showing her adult students and coworkers that you can thrive while balancing being a new parent and having to work.

The previous principal at ALA resigned in March, and Wilkinson was asked to fill the position in the interim—just a few months after giving birth to her daughter Clementine, who was born in November of last year.

“I am a first-time mom. I was a little terrified about coming back to work. When you’re on maternity leave, it’s great because you can keep the focus entirely on your baby. And when you’ve never been a mom before, you just never know the challenges that you’re going to have to deal with,” said Wilkinson.

“However, the great thing about maternity leave is, it gave me the time to get a handle on things and to help me build the confidence in myself. Then it was like, ‘Okay, I can go back to work, and I can still manage being a mom.’ And of course, the Community policy of being able to [bring her daughter to work] is invaluable. In terms of being with her every day, it does require some flexibility, but it’s nice for ALA students and other staff to see that you still can get the work done with a baby around.”

Wilkinson joked that having her baby on the job is almost like having a therapy dog, because the baby brings a positive energy to the workplace.

There is a plan in the works to bring

This was helpful to student-parents who were looking for ways to continue their education while raising a child.

“The great thing is the schools are always doing their best to accommodate the students,” said Wilkinson. “We do have a few students currently attending the ALA who are parents, so they have little ones at home.”

The Eagle’s Nest is in the brainstorming phase, with the goal of staffing up and getting the room ready to go in the next school year or two.

Wilkinson has been in education for 15 years, and 13 of those have been in the Community. She previously taught at Salt River High School, then worked on the education side of Human Resources. After that she served as the dean of students at the ALA, and for the last six years she has worked at Salt River Elementary School as the assistant principal.

Community Artist's Artwork Gets Rededication at Hayden House

After more than a year of restoration, the historic Hayden House in Tempe has reopened and is now home to the offices of the Downtown Tempe Authority.

The Hayden House, originally built in 1873, is the oldest continuously occupied building in Maricopa County and served as Monti's La Casa Vieja restaurant beginning in the 1950s until it closed in 2014. The adobe structure now has been restored to its 1924 appearance.

On April 10, the City of Tempe hosted an official dedication of the gate artwork at the Hayden House, which was created by Salt River Pima-Maricopa Indian Community artist Jacob Butler last year.

The name of the artwork is "Akimel Gahiobs" ("river crossing" in O'odham). The steel panels on the wall are an homage to the hard bottom Onk Akimel (Salt River) crossing point located north of the Hayden House property.

Tempe pioneer Charles Hayden ferried passengers and goods across the river at this point and leveraged the flow of the then-undammed waterway to power his flour mill.

The artwork's panel images mirror the landscape of the surrounding area with key features depicted, such as Oidbad Do'ag (Tempe Butte), the Hayden House and the akimel gahiobs. The piece celebrates and honors the significance of the akimel gahiobs area as a commerce and travel route utilized by the O'odham, their ancestors and other Indigenous peoples of the Southwest.

"I was fortunate enough to be asked to fulfill the artwork that represented the connection. This piece [the gate artwork] is just metal on the ground. What really matters is the plaque that honors and acknowledges the tie that we have to this land. Today, that's what I think this is all about. The acknowledgement," said Butler at the dedication. "Land acknowledgements are awesome. When they first came out, I celebrated them myself. But a land acknowledgement without the backing of action is just words, and so through this plaque [the City of Tempe] is taking that step to honor the land acknowledgement they state in their activities. This was an idea that came from [the former City of Tempe historic preservation officer John Southard] and deputy community development director-special projects Alex Smith, in coordination with the Four Southern Tribes and specifically Shane Anton. It was something that they wanted to do when they were doing the mitigation of this building to honor the ancestral ties we have to this land. They found very distinct archaeological resources here that they haven't found anywhere else."

Notable speakers and attendees at the dedication included SRPMIC Vice-President Ricardo Leonard, Vice-President of the Tohono O'odham Nation Wavallene Saunders, Salt River Royalty and Basket Dancers, SRPMIC Tribal Preservation Officer Shane Anton, City of Tempe Councilmember Doreen Garlid, and Tempe Mayor Corey Woods.

"I want to remind everyone that we are here today to celebrate two very important things. First of all, to dedicate the new artwork by Mr. Butler. We had

an opportunity to meet a few months ago when he first unveiled this, and we really wanted to make sure that we did a larger ceremony celebrating the work he's done, not just here for this one art piece, but for the City of Tempe for so many years," said Woods. "He's been a very important part of the culture and the history of the city, and we want to make sure that we properly acknowledge him today with this ceremony."

SRPMIC member Leland Thomas began the ceremony by singing a special traditional song for the occasion.

"On my way here, I was trying to figure out what I wanted to sing. I think I needed to see what his artwork was

in order to give me that insight. The song I'm going to sing has to do with the kickball. I think it gives a perspective to Jacob; he's always moving and always going," said Thomas. "And what pushes him and what I see in his artwork is always the people of our past, because that drives him. This song says, 'As I'm running toward this mountain, I hear the voices and the echoes of the people,' and it's the people cheering him on. This runner, he's running towards the end and they're giving him more encouragement and that push. I always see that in Jacob's work; his connection to his past gives him his push to continue to do what he needs to do."

Council Enacts Ordinances to Implement Special Domestic Violence Criminal Jurisdiction

the VAWA Reauthorization of 2013.

The changes that may come in the future would be anything that expands tribal jurisdiction according to VAWA 2022, which would be the new subsections that allow the Community to prosecute child violence, sex trafficking, sexual assault and more.

“What’s important for the Community to know is that for years and years, people have been coming to my office for help with these cases. Their husbands, significant others or children’s fathers were abusing them or their children, and they were coming to us for help and we weren’t able to give them any because we didn’t have criminal jurisdiction,” said SRPMIC Community Prosecutor Alane Breland.

“We could help them seek orders of protection or get financial help if they wanted to move, but in terms of real, concrete, black-and-white assistance from law enforcement from our office, we weren’t able to help. We had to rely solely on the federal system.

“Council has now passed laws that allow us to now help those domestic violence victims, and should Council decide to go further under VAWA 2022, it would further enable us here in the Community to hold people responsible who commit other very dangerous crimes against vulnerable victims, whether they be children, vulnerable adults or intimate partners,” Breland continued. “I think that, from a policy perspective, being able to hold offenders responsible in the community where they commit those crimes, rather than having to depend on an outside agency, the U.S. Attorney’s Office, is an important consideration to make.”

SRPMIC 12 Percent Committee Presents Funds to Arizona Autism Research & Resource Center

On April 14, the Salt River Pima-Maricopa Indian Community’s 12 Percent Gaming Grant Committee presented a check for \$12,000 to the Southwest Autism Research & Resource Center (SARRC) during SARRC’s community breakfast at the Arizona Biltmore Resort’s Frank Lloyd Wright Ballroom.

SARRC is a nonprofit that conducts research, provides evidence-based practices, disseminates effective training and builds inclusive communities for individuals with autism and their families. SARRC is one of the only autism organizations in the world that provides a lifetime of services for individuals and their families while conducting cutting-edge research.

Gaming in Arizona is governed by the Arizona Tribal-State Gaming Compacts between the state and all 22 federally recognized Arizona tribes.

Under Arizona’s gaming compact, tribes with casinos contribute 12% of their gaming revenue each year to the state, and to cities, towns and counties. Contributions are determined on a sliding scale based on the amount of gaming revenue realized each year.

The remaining 88% of the tribe’s total annual contribution goes to the Arizona Benefits Fund on a quarterly basis and provides funding for the Arizona Department of Gaming and its Division of Problem Gambling. The remaining funds are directed toward instructional improvement for schools, trauma and emergency care, tourism, and wildlife conservation, as detailed in the Tribal Contributions Distribution Flow Chart.

“Part of that revenue share is controlled by each individual tribe to recognize and partner with nonprofit organizations,” said Gary Bohnee, special assistant for Congressional and Legislative Affairs with the SRPMIC Office of Legislative Affairs.

“[Every year], the committee makes decisions and selections on organizations that are worthy and deserving of community funding. It’s a requirement of the compact and it gives the opportunity for tribes to look

at organizations that it would like to see funded.”

The Community’s committee policy focuses on areas such as education, cultural resources, economic development, veterans and a number of other categories.

The framework of the policy in place outlines several areas that the committee and the Community ultimately will consider, and SARRC’s mission aligns with that framework.

“Former SRPMIC President Delbert Ray Sr. once said that the Community is helping people that it will never meet. That’s the goal, to reach out and meet needs in the Community. A lot of people who are served by these organizations, we’ll never be able to meet them. It’s putting money to good use. Autism is prevalent in the community at large, and so the [SRPMIC] can help with the efforts and the mission of the organization,” said Bohnee.

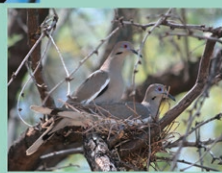
The Conscientious Trimmer

It's that time of year again. Springtime! Warmth is in the air, birds are singing, and plants are growing. With the birds singing comes nesting season. Nesting season is when birds pair up, build a nest and raise their young. For most of the birds, that occupy the

hummingbirds, or massive, a foot or two across for hawks and owls.

Springtime also marks the start of a lot of yard work. As the season moves forward, trimming trees back can be a necessity in preparing for monsoon season. When doing springtime yard work, trimming and pruning trees and shrubs, try to remember the birds. They share your love of those trees and shrubs. Before you cut, take a quick break and check the branches for nests, don't cut branches that have nests on them, and try to make sure any cut branches won't hit a nest as it falls. Checking for nests and avoiding them gives the birds that call the trees and shrubs "home", time to raise their families.

WOLF Teens Help Give the Pollinator Gardens New Life

During the week of Earth Day, Way of Life Facility's (WOLF) Youth Services Teens volunteered to help plant pollinator-friendly plants within the pollinator gardens at the Community's demonstration treatment wetlands. One group of students planted at the Cottonwood Wetland located in the Salt River District, while the other planted at the Lehi Wetland located in the Lehi District. The students learned about the Wetlands, how to properly plant, and about pollinators and the plants they enjoy.

Over time, the pollinator gardens will provide habitat for pollinators such as the many variety of bees, butterflies, moths, beetles, flies, hummingbirds, and bat species. Through the years, the U.S. has seen great declines in pollinator species, putting many of them at risk for extinction. Declines are due to habitat loss and climate change, resulting from human impacts. The



creation of these pollinator gardens provides an opportunity for these species to thrive. Pollinators do their job by pollinating the plants that provide us humans the many foods we enjoy.

For the past several years, Community Development Department's Environmental Protection and Natural Resources Division (CDD-EPNR) has received plants from the Scottsdale Community College (SCC) greenhouse. Through varying seasons, SCC grows a variety of native plants that CDD-EPNR uses to promote environmental conservation and for restoration projects within the Community. CDD-EPNR and SCC will continue to partner to bring plant diversity and habitat for pollinators and wildlife species to our beautiful Community.
